Contributors. Nicholas Griffin is a post-doctoral fellow at Victoria University of Wellington, New Zealand, and did his graduate work in philosophy at the Australian National University in Canberra. He contributed "Russell's Later Political Thought" to Russell 5, and reviews russelliana for The Spokesman. Merrilee H. Salmon is assistant professor of philosophy at the University of Arizona in Tucson. She presented a version of her paper to the American Philosophical Association in April 1975. Desmond King-Hele, F.R.S., researches at the Royal Aircraft Establishment (U.K.) on the upper atmosphere and the earth's gravitational field. His latest book is Poems and Trixies (1972). Douglas Lackey, editor of Russell's Essays in Analysis, teaches philosophy at Baruch College in New York. He has been striving heroically to persude E.P. Dutton Co. to reprint What I Believe for distribution by the Bertrand Russell Society.

A manuscript in your attic? Constance Malleson wrote that she thought there was a manuscript by Russell in her attic. She got someone to search for it. The 227-page manuscript of Introduction to Mathematical Philosophy turned up, along with the printer's copy of the typescript of Russell's long review of Dewey's Essays in Experimental Logic. Both were written in Brixton Prison, 1918. McMaster has acquired the items.

Forthcoming books. Ronald W. Clark's Life of Bertrand Russell is in the last stages of production. Publication is set for October 30th. Besides being an encyclopaedic study of nearly 800 pages, it offers revelations, insights and reviews of any espects of Russell life and work. At once highly readable, accurate and fully referenced, Clark's biography will be the Russell scholar's handbook for decades to come. British publishers are Jonathan Cape/Weidenfeld and Nicolson; the American is Knopf. Dora Russell's autobiography, The Tamarisk Tree: My Quest for Liberty and Love, will be published on July 10th by Elek/Pemberton in the U.K. Katharine Tait's study, My Father, Bertrand Russell, is due to be published later this year. The Bertrand Russell Peace Foundation has reprinted Justice in War-Time.

<u>Visitors and researchers</u>. Irving M. Copi, Cyrus Eaton, Sir Frederick Dalmont, Noam Chomsky, The Bishop of Niagara, Katharine, Andrew and Benjamin Tait, Carl Spadoni, Alan Blackwell and Jim Levey were recently in the Russell Archives.

Two McMaster lectures on Russell. The Bertrand Russell Society local and the McMaster Philosophy Circle presented talks by Katharine Tait and Elizabeth Ramsden Eames on March 26th. Dr. Tait spoke of how her father's educational principles had worked out in her case, entitling her talk "The Guinea Pig Speaks". Professor Eames (of Southern Illinois University) lectured on "The Interaction of Russell and Wittgenstein".

The BRPF's appeal. The financial base of the Bertrand Russell Peace Foundation is being attacked on two fronts. Inland Revenue is challenging the settlement of part of Russell's resources on the BRPF, and the local authority in Nottingham has put a compulsory purchase order on Bertrand Russell House. Lady Russell is appealing for funds. It is a pity that the BRPF staff should be occupied in legal and financial battles rather than their practical political work, though that goes on.

Russell-Morrell correspondence. The embargo on Lady Ottoline Morrell's 1600 letters to Russell expired on February 2nd. A microfilm of Russell's nearly 2000 replies is also now available to researchers. Thanks are due to Lady Ottoline's daughter, Mrs. Julian Vinogradoff, who permitted the exchange of microfilm with the Humanities Research Center of the University of Texas.
