1984. It being the New Year as these notes are written, we have the obligatory item on George Orwell, but with a difference. It is Russell's blurb for 1984, which appeared on the dust-jacket of the first edition:

Nineteen Eighty-Four depicts, with very great power, the horrors of a well-established totalitarian regime of whatever type. It is important that the Western World should be aware of these dangers and not only in the somewhat narrow form of fear of Russia. Mr. Orwell's book contributes to this important purpose with great power and skill and force of imagination.

**Erratum**. On p. 79 n. 2 of the last issue I stated that the "Catalogue of the John G. Slater Collection of Monographs by Bertrand Russell" was dated July 1973. This was an error for July 1983.

The Collected Papers. Cambridge Essays, 1888–99, the first volume of The Collected Papers of Bertrand Russell, was published on 24 November 1983. The first plans for the series appeared in Russell exactly ten years

ago. It is worth rereading the late William Ready's prefatory note from that issue. Most of it still applies. We didn't, in the end, get the collectors' edition, bound in morocco, blue and gold, but the blue binding is almost as fine, and the top edge is even gilt.

The second Russell Archives. The Catalogue of the Second Archives of Bertrand Russell is now complete in camera-ready form and runs to 460 pages. Some 72,200 documents are dealt with under a classification scheme with 69 main headings. One feature that is expected to be most useful is the comprehensive index of some 14,000 names.

New acquisition. McMaster has purchased the uncorrected galley proofs of the Simon and Schuster edition of *Human Knowledge: Its Scope and Limits* (1948). Why buy the uncorrected proofs? Because in correspondence with the publisher Russell objected to the copy-editing of his typescript and requested that his copy be returned to on most occasions where the galleys differed. He so marked his proofs, which do not survive. His typescript does, however, and so, of course, does the published book. Extensive material is now available, therefore, for research into what publisher's alterations in phrasing, spelling and punctuation Russell objected to. Improved knowledge of Russell's strong stylistic preferences would be useful in editing his writings.

New books. Volume 2 of Barry Feinberg and Ronald Kasrils' Bertrand Russell's America: 1945–1970 was published in the fall by South End Press in Boston.

From the number of works in progress, it would appear that the *Collected Papers* are emerging just at the time of a new interest in Russell studies. The edition will provide the new generation of Russell scholars with full and reliable texts.

The BRS at the APA. The Bertrand Russell Society announces a call for papers to be presented at its meeting at the Eastern Division of the American Philosophical Association in December 1984.
