Andrew Brink is Professor of English at McMaster University and an editor of *The Collected Papers of Bertrand Russell* currently collaborating on Volume 12, *Contemplation and Action*, 1902–14. He is also an Associate Member of the Department of Psychiatry, McMaster University Medical Centre.

Peter Clarke is a Fellow of St. John's College, Cambridge, and University Lecturer in the Faculty of History. He is the author of *Lancashire and the New Liberalism* (1971) and *Liberals and Social Democrats* (1978). He is a frequent contributor to the *London Review of Books* and the *Times Literary Supplement*.

Nicholas Griffin is Associate Professor of Philosophy at McMaster and an editor of *The Collected Papers of Bertrand Russell* currently at work on Volumes 2 and 3. The author of *Relative Identity* (1977), he has written many articles on Russell, particularly his philosophy of logic. He recently returned from the Australian National University where he was a Visiting Fellow in the Philosophy Department of the Research School of Social Sciences.

Brian Harrison has been Fellow and Tutor in Modern History and Politics at Corpus Christi College, Oxford, since 1967. His publications include *Drink and the Victorians* (1971), *Separate Spheres* (1978), and *Peaceable Kingdom* (1982). He is now writing on the history of British women's organizations since 1800.

Thomas C. Kennedy is Professor of History at the University of Arkansas, Fayetteville. His articles on the effects of militarism and the peace movement on modern British society have appeared in numerous history journals. His book, *The Hound of Conscience: A History of the No-Conscription Fellowship*, was published in 1981. Dr. Kennedy is currently T. Wistar Brown Fellow at Haverford College where he is working on the "Quaker Renaissance", a study of the revitalization of the British Society of Friends between 1880 and the 1920s.

His Ph.D. on Russell's early philosophy was completed at the University of Waterloo in 1978; he obtained an M.L.S. from the University of Toronto in 1980. An editorial associate of *Russell*, he frequently contributes to that journal and on bibliographical topics to a variety of other journals.

Kirk Willis is a member of the Department of History, University of Georgia. His doctoral dissertation, completed at the University of Wisconsin in 1982, is entitled "Bertrand Russell: An Intellectual Biography 1872–1914". He is revising his dissertation for publication by Harvard University Press. He recently finished an article, "Bertrand Russell on History: The Theory and Practice of a Moral Science".
