Irving H. Anellis is an historian of logic specializing in algebraic logic and mathematical logic. He has been Visiting Research Assistant and (since 1989) a consulting editor in logic and mathematics at the Peirce Edition Project, Indiana University–Purdue University at Indianapolis, and serves on the advisory board of the Hilbert–Bernays Project. His recent publications include “Russell and His Sources for Non-Classical Logics” in *Logica Universalis* (2009) and “MacColl’s Influences on Peirce and Schröder” in *Philosophia Scientiae* (2011). His “Logique et la théorie de a notation (sémiotiques) de Peirce” is forthcoming in Jean-Yves Béziau, ed., *La Pensée symbolique* (2012).

Kenneth Blackwell is Honorary Russell Archivist and Adjunct Professor of Philosophy at McMaster University. Editor of *Russell* since 1971, he was Textual Editor of Volume 1 of Russell’s *Collected Papers*. He is author of *The Spinozistic Ethics of Bertrand Russell* (1985), coauthor of *A Bibliography of Bertrand Russell* (1994) and, in this journal, author of “Russell’s Mathematical Proofreading (1983)”, “A Bibliographical Index for *Principia Mathematica*” (2005) and “Variants, Misprints and a Bibliographical Index for *Introduction to Mathematical Philosophy*” (2009).

Ryan Christensen is Assistant Professor of Philosophy at Brigham Young University. His work is mainly on truth and related topics in language, logic, and metaphysics.

Nicholas Griffin is Director of the Bertrand Russell Research Centre and Canada Research Chair in Philosophy at McMaster University. He is the General Editor of *The Collected Papers of Bertrand Russell* and is currently working with Sébastien Gandon on an edition of the Whitehead–Russell correspondence.

Brice Halimi is an Assistant Professor in the Philosophy Department of Paris Ouest University. He works mainly in philosophy of logic and philosophy of mathematics. He is part of a translation project of *The Principles of Mathematics* into French.

Bernard Linsky, Professor, Department of Philosophy, University of Alberta,

assisted with organizing the *PM@100* Conference where he presented a preview of his *The Evolution of Principia Mathematica: Bertrand Russell's Manuscripts and Notes for the Second Edition* (Cambridge U. P., forthcoming 2011). He has written papers on the theory of definite descriptions and an earlier book, *Russell's Metaphysical Logic* (Stanford: CSLI, 1999), which are mentioned in some papers in this issue. He is coauthor, with K. Blackwell, of "New Manuscript Leaves and the Printing of the First Edition of *Principia Mathematica*" in this journal, and of an article in the *Stanford Encyclopedia of Philosophy* on the notation in *Principia Mathematica*.

Conor Mayo-Wilson is a PHD student in Logic, Computation, and Methodology at Carnegie Mellon University. His primary interests include philosophy of science, philosophy of mathematics, and logic.

Roman Murawski is Professor in the Faculty of Mathematics and Computer Science of Adam Mickiewicz University in Poznan, Poland. He has studied mathematics, philosophy and theology. He works in mathematical logic and the foundations of mathematics as well as in the philosophy of mathematics and history of logic.

Ray Perkins, Jr. is Professor of Philosophy at Plymouth State University in Plymouth, New Hampshire. He is currently Vice-President of the Bertrand Russell Society. His book *Yours Faithfully, Bertrand Russell: a Lifelong Fight for Peace, Justice and Truth in Letters to the Editor* received the 2002 Book Award of the Bertrand Russell Society. He published "Why 'On Denoting'?" in *Russell* (2007).

Graham Stevens is Senior Lecturer in Philosophy at the University of Manchester. He is the author of *The Russellian Origins of Analytical Philosophy* (Routledge, 2005) and numerous articles on Russell and other topics in philosophy. His book *The Theory of Descriptions* is forthcoming in August 2011 (Palgrave Macmillan).

Russell Wahl is Professor of Philosophy at Idaho State University. He has published various articles on the history of analytic philosophy and on early modern philosophy, including most recently "Occasionalism, Laws and General Will" (2011), "Port Royal: the Stirrings of Modernity" (2008), "'On Denoting' and the Principle of Acquaintance" (*Russell*, 2007), and "Occasional Causes" (2007). He is currently working on Russellian analysis and logical constructions and was a visiting professor at the Université Blaise Pascal, Clermont-Ferrand in March 2011.
